

And this will probably be our last event at the Homestead.

As most of you know, we lost a really good guy, friend and CBA member to a wreck that was senseless. The woman was on Todd Farkas side of the road and hit him head on. We've all had a friend or relative that has died or seriously injured from a neglectful driver, but we continue to ride because that is what we love to do. Todd didn't have any insurance life except the FREE accident policy that CBA/ABATE of NC provides it's members. Also he didn't specify a beneficiary. We encourage you to name a beneficiary for your insurance with us. Also this company has a number of good additional policies that you might be interested in. This insurance is just one of many good reasons for you to belong to the CBA.

This past weekend—Buncombe County CBA had their annual Hot Springs Rally. If you have never been—you need to put it on your calendar for next June. They really do a "bang-up" job. Peewee & I enjoy this bike rally better than any other that we have attended. It's where "true" bikers come together as friends and just have a relaxing good time. I hope Creekside will continue to grow and become such a rally right in our own backyard. It can with your support.

As I stated in my first paragraph, this is the most difficult column and decisions that our Homestead Committee and CBA Officers has had to make. As of July 15th, the CBA will no longer meet at the Gaston County Homestead because it will no longer be in our hands. We just simply can't continue to borrow money from the CBA to pay the expenses for the Homestead. We have tried to get your support back, but it hasn't happened. Therefore we are left with the only decision we can make—close the Homestead. It has been our home for a number of years and we've had some really good times there, but it seems the "biker" community has changed in the last couple of years. A lot of bars now cater to bikers and a lot of "man caves" have popped up taking support from us. We had a good run and all bikers were welcome with minimal drama. Usually the drama was from non CBA members. We never wanted drama but sometimes it comes with the territory. All good things come to an end. It has been very hard for us to keep it going with only a few people helping the officers out. Our expenses were only approximately \$1000-\$1100 a month and we were just not bringing that in. We have some equipment & supplies that we are going to try and sell to repay the CBA some of what we have borrowed over the last year. Also we have some things that we need to find space for. Probably a storage unit centrally located for the officers to have access to it. We don't want to store our stuff at anyone's house because you can't tell what the future will hold for any individual. July 15th will be our last day for us at the Homestead.



The Gaston CBA worked hard and were proud to have someplace to call home. And now I really don't understand where that enthusiasm went. I want to thank all the members and friends who supported the Homestead through the years and to those that paid their pledges to help us keep it open as long as we have. If everyone would have paid that made a pledge, we might have made it—but it is what it is. It's sad that there will be no more CBA meetings. parties or benefits at the Homestead. I know this is awful of me to say, but I hope the bikers in this community that quit supporting the Homestead will come to regret not supporting this great place. Bars are out for profit. We only wanted to survive by paying the bills but it didn't happen. It's sad.






