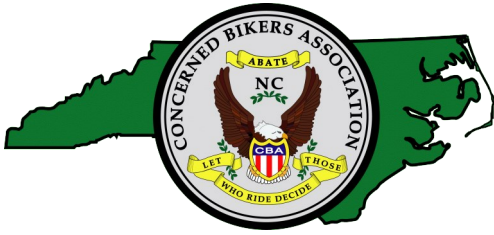

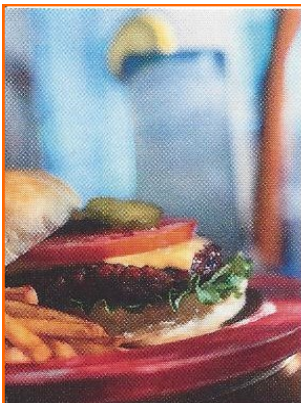

President's Message—

OUR MEETING DAY & TIME IS THE 2ND TUESDAY EVERY MONTH AT 7PM. Our November meeting will be held on the 14th at a NEW location. Hillbilly's, 930 E. Garrison Blvd., Gastonia NC 28054 will be our new home for officers & general meetings. Please mark this on your calendar.

In last month's newsletter, I wrote about Hurricane Harvey and the devastation that it caused in Texas and Louisiana. Little did we know that Harvey was only the beginning of a month that was so terrible with Irma in Florida and the Caribbean Islands, Puerto Rico with a direct hit from Maria, Nate with his flooding and damage on the gulf coast (although we got some much needed rain) and last but not least—Las Vegas and one of the most terrible acts of violence imaginable. Nature we can understand because we have no control over it but the terrible loss in Las Vegas is something out of a horror book. Are you shocked as to how a man can take that many innocent lives? I know I am. It's so unbelievable that it happened and we will probably never learn the reason this man did what he did. For those dear people that lived in the path of those hurricanes and in the horror of a man that had to be mentally unstable because surely a sane man couldn't do such a horrible act, we remember them in our hearts.

During October, CBA/ABATE of NC loss one of it's most dedicated warriors in a motorcycle wreck — Thomas "Doc Ski" Wasileski. Doc Ski taught us how to stay positive in the world of the General Assembly in NC. He also taught us the love of the Constitution and how it benefits us. "He was a stalwart protector of freedom. He did so many things for others; I doubt any one person knows the extent." (*Cynthia Hodges*) He fought for his Country as a Green Beret for 17 years so that right there earns him our respect but he also fought for bikers across this country and nothing (not even cancer) could stop him. All that knew him grieve for "our" loss. Yes I said "our" loss because it is a terrible loss of a friend and a warrior who fought a great battle on behalf of all of us. He was a true "Champion of Freedom." Our Sympathy goes out to his family and his many, many friends in NC and across this Country.

There is an article in this issue about the Waco motorcycle tragedy in May 2015. I'm not going to recap all of what happened here in this column but do go online and read about it. And be sure to read it from both sides of the aisle. One thing that really bothers me is it's been nearly 2 1/2 years since this happened and they are just now (September) starting the trails. This is not just about any one motorcycle club and what happens with the prosecution but it's far reaching impacts on the entire culture of all motorcycle clubs and organizations and our 1st Amendment issues of expression and association. The first trails could also have far reaching impact on the future trails. If the prosecution succeeds, then this can and probably will impact motorcyclist across the US. There is also another problem with Texas that is an assault on fundamental 1st and 2nd Amendment rights. A Travel Advisory has been issued to all members and associates of motorcycle clubs traveling in or to the state of Texas that there is a legitimate risk of being arrested for Unlawful Carrying of a Weapon in the State of Texas solely because of membership or association. Here is another problem that can stick it's ugly head into our state if we are not careful. Now I hear you saying: "Well this doesn't concern me at all because I'm not a member of a motorcycle club or associate with any." Where do you think this will end? If they try to destroy the clubs, what makes you think they won't come after all motorcyclist on the 1st, 2nd & 8th Amendment here? How do we stop this injustice from happening here in NC & SC? We join CBA/ABATE of NC or ABATE of SC (both is preferred). We also join the MRF (Motorcycle Rights Organization). I know this might seem like a lot of organizations I'm asking you to join, but if you really want to protect your freedom—you will join! It won't cost you any more than a night on the town (maybe less). Your membership will give our Legislative Directors more leverage in Raleigh, Columbia and Washington DC. Numbers count. If you don't get "online" or you don't have a computer, just give me a call and I will send you Gaston's and/or any other motorcycle rights organization application that you desire to join. Plus all of these organizations provide accidental death insurance FREE of charge to members.

November is a time that most of us come together with our families and give thanks for what we have and our freedom. This community of bikers is and always has been a family. Some of us are closer to our "biker" family than we are our own. We are concerned when one of us is hurt or sick, we grieve when one of us dies and we celebrate when one of us achieves good or finds love. Please don't ever let that disappear from our community.

It also ensures that the EPA can't get their nose in and start regulating motorcycles at the racetrack!

Get Out of My Gas Tank!

Ten years ago, Congress expanded the Renewable Fuel Standard or RFS. The RFS has resulted in gasoline with higher blends of ethanol (E15, E85) being integrated into our nation's fuel supply. The result? Our motorcycle engines are suffering. Tell your elected officials that WE NEED CHANGES to the RFS. This affects other small gasoline powered engines as well (lawn mowers, boats, jet skis, etc.).

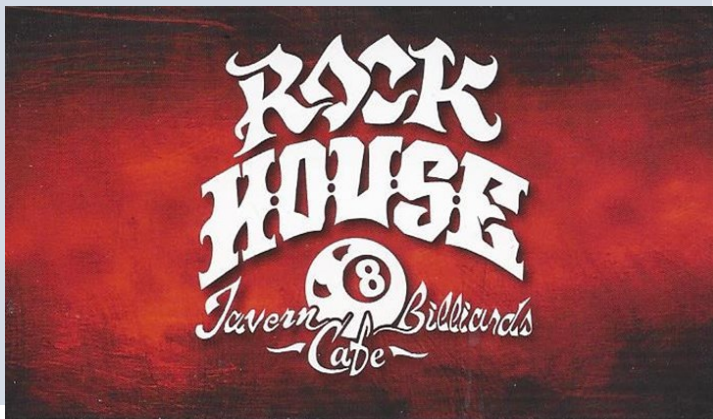

Things to Remember:

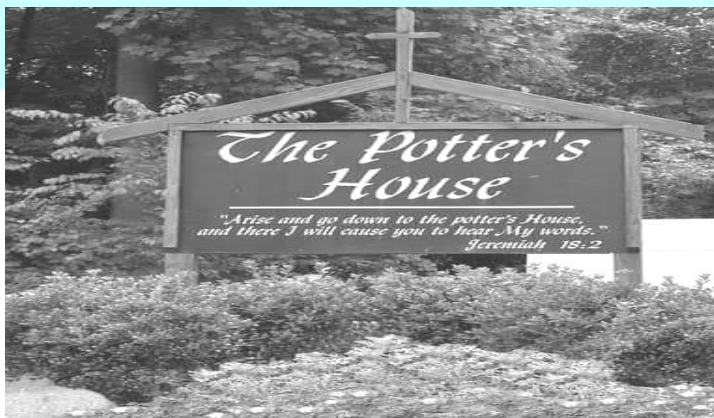
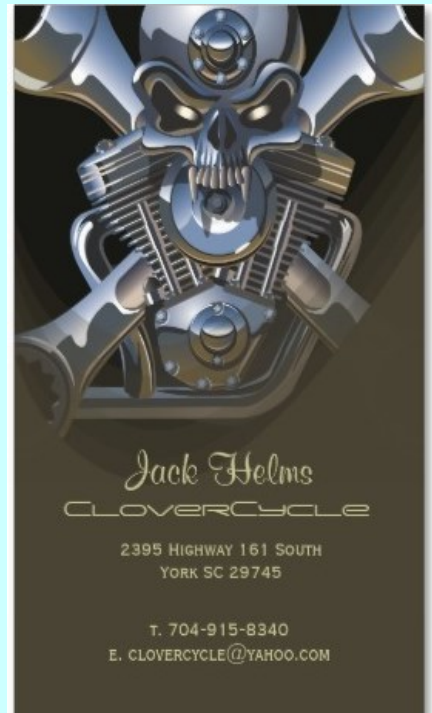
- * *Acknowledging their malicious comments gives them power.*

LEGISLATION:

HELMET LAW:

We still have a bill in the legislature, that is HB91 You can find the text at [House Bill 91](#) . This bill now resides in the House Rules committee. We are looking for an avenue to bring this bill back out in the 2018 session. If all the motorcyclists that want to ride free would join the Concerned Bikers Assoc., we would have that freedom. As long as they sit back and wait for others to do it, we will have a difficult time getting this passed into law.

NORTH CAROLINA TO PROVIDE DRIVER INSTRUCTION ON LAW ENFORCEMENT STOPS:

Similar to a measure recently adopted in Louisiana to teach new licensees how to interact with police during traffic stops. House Bill 21 "Driver Instruction/Law Enforcement Stops" has been approved unanimously by the North Carolina legislature and signed into law by Governor Roy Cooper on July 12, 2017.

HB 21 provides that "The Division, in consultation with the State Highway Patrol, the North Carolina Sheriff's Association, and the North Carolina Association of Chiefs of Police, shall include in the driver license handbook a description of law enforcement procedures during traffic stops and the actions that a motorist should take during a traffic stop, including appropriate interactions with law enforcement officers.

If you are interested in serving on the Legislative Committee for Gaston, Please contact Donna or Jill. Legislation is the backbone of our organization and it can be an exciting and frustrating at the same time.

The 2018 session is what they call the "short session" so not much will happen this coming year. Unless a bill has "money" connected with it, it will not be heard.

There will be a training session on how a bill gets through the General Assembly in Winston-Salem on 11/18/17.

The public is invited. There is information on this event in this newsletter. We do hope you will come, learn and help celebrate the Chapters in the CBA/ABATE of NC.

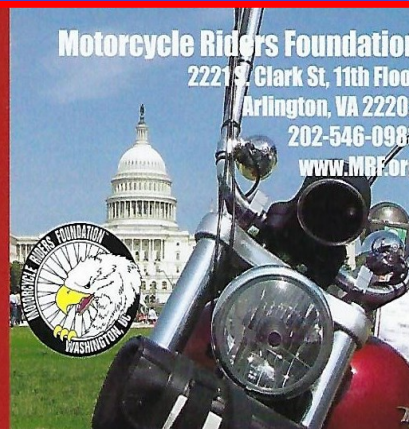

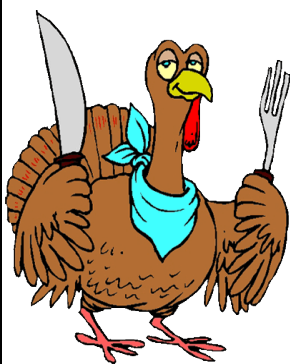

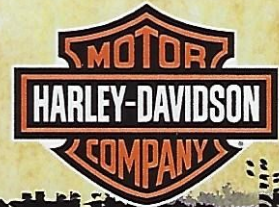

Bill of Rights in Simple Language

AMENDMENT 1

Congress can't make any law that:

- I- Favors one religion over another religion, or no religion at all, or opposes any religion;
- I- Stops you from practicing your religion as you see
- I- Keeps you from saying whatever you want, even if you are criticizing the President of the United States;
- I- Prevents newspapers, magazines, books, movies, radio, television or the internet from presenting any news, ideas, and opinions that they choose;
- I- Stops you from meeting peacefully for a demonstration or protest to ask the government to change something.

AMENDMENT 2

Congress can't stop people from having and carrying weapons.

AMENDMENT 3

You don't have to let soldiers live in your house, except if there is a war, and even then Congress needs to pass a law and set the rules.

AMENDMENT 4

Nobody can search your body, or your house, or your papers and things, unless they can prove to a judge that they have a good reason for the search.

AMENDMENT 5

Except during times of war or if you are in the military:

- I—You can't be tried for any serious crime without a Grand Jury meeting first to decide whether there's enough evidence against you for a trial;
- I— If at the end of a trial, the jury decides you are innocent, the government can't try you again for the same crime with another jury;
- I—You cannot be forced to admit you are guilty of a crime and if you choose not to, you don't have to say anything at your trial at all;
- I—You can't be killed, or put in jail, or fined, unless you were convicted of a crime by a jury and all of the proper legal steps during your arrest and trial were followed; and
- I—The government can't take your house or your farm or anything that is yours, unless the government pays for it at a fair price.

AMENDMENT 6

If you are arrested and charged with a crime:

- I-You have a right to have your trial soon and in public, so everyone knows what is happening;
- I- The case has to be decided by a jury of ordinary people from where you are, if you wish;

AMENDMENT 6 (continued)

I-You have the right to know what you are accused of doing wrong and to see and hear and cross-examine the people who are witnesses against you;

I-I You have the right to a lawyer to help you. If you cannot afford to pay the lawyer, the government will.

AMENDMENT 7

You also have the right to a jury when it is a civil case (a law case between two people rather than between you and the government).

AMENDMENT 8

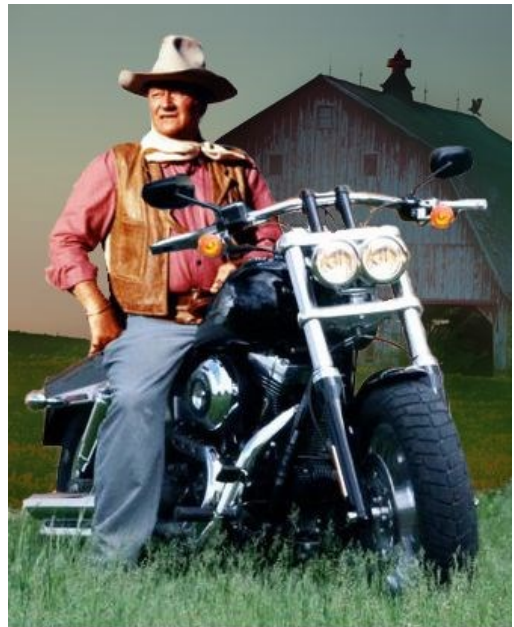
The government can't make you pay more than is reasonable in bail or in fines, and the government can't inflict cruel or unusual punishments (like torture) even if you are convicted of a crime.

AMENDMENT 9

Just because these rights are listed in the Constitution doesn't mean that you don't have other rights too.

AMENDMENT 10

Anything that the Constitution doesn't say that Congress can do, is left up to the states and to the people.

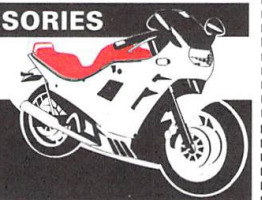

WACO TRAGEDY

As a reminder about current (and past) events, it has been nearly two and one-half years since the Waco tragedy.

Shortly after noon on May 17, 2015, something happened involving several different motorcycle clubs, independent riders and law enforcement at a Twin Perks restaurant.

The restaurant was to be the location for a meeting of Texas Coalition of Clubs and Independents (TCOC&I) to help educate bikers about legislation and how they could work with their representatives in Austin.

Nine bikers were killed, twenty were wounded and 177 were arrested and held on \$1 million bond with a charge on engaging in organized criminal activity, including those not associated with any motorcycle club, but unfortunate enough to have just arrived in the parking lot after the melee and shooting. These bonds was a clear violation of the 8th Amendment.

After two year and one-half years, the trails are just now starting but the judge that was supposed to hear the first case has been recused and the second judge that was to take his place has also been challenged.

Survivors of the shootout have lost jobs, had vehicles seized, lost leases on residences, some were questioned about their ability to safely raise children and have lost custody of them. Those released with ankle monitoring devices have had to pay for the privilege. \$100 installation fee and \$255 a month for as long as they wear the devices. The only winners so far are the bail bondsmen and those installing ankle monitors.

Ballistics reports seen by The Associated Press show that four of the people killed were struck by bullets from Waco police rifles, and that two of them were struck only by bullets fired from police weapons.

A grand jury in September 2016 declined to recommend charges for the officers after they were cleared by an internal investigation.

"Remember Waco" patches are available on several patch websites. Waco is a long way from us, but the ramification of these trails could also hit home in the future.
