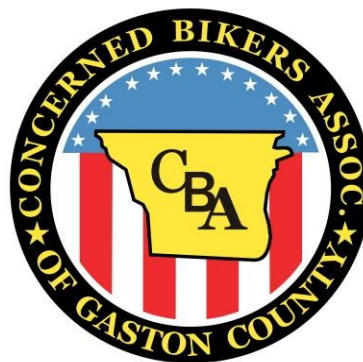

Your input is very important and only takes a few minutes. Dave Terwilliger has been appointed as the new State Legislative Director and was unanimously at the State Executive Council Meeting on January 23rd. Lobby Day 2021 in Raleigh should be set at the January 23rd state meeting. It is tentatively set for March 24th.

VICE PRESIDENT'S CORNER—

"Women Riders" Never 2 OLD 2 LEARN TO RIDE

Riding motorcycles has become far more prevalent among women. Approximately 25% of motorcycle owners are women.

Recently searching the internet on older women riders, I ran across Gloria Struck 95+ years, she has been riding since she was 16. Known as "The Legend," she was a early member of The Motor Maids (an all women motorcycle riding club) since it was established in 1940. Inducted into the AMA Motorcycle Hall of Fame, wrote a book (A Lifetime Motorcyclists 75 Years On Two Wheels and Still Riding). She doesn't trailer her bike. Lifetime mileage somewhere around 650,000+ miles. Once she reaches 100 years old, she plans to ride cross-country. She speaks at Motorcycle rallies to promote her book and share her life story. And society believes WOMEN DON'T RIDE MOTORCYCLES! Gloria Struck is One Tuff Act to Follow.....I hope to meet her one day.

Hey, I do know a local woman rider that's One Tuff Act to Follow. She's been around the block a time or two. Riding since she was 12 year's old. Some people called her Honda Honey, Gummy Bear, Smurf and Babe Ruth, but none of those road names stuck! But.... Ruthie Michalak sure did.... Ruthie, my dear friend actually gave me my road name in 2009 when I joined the Gaston County CBA and joining up with The Gaston County Toy Run for Kids. Unlike her road names, mine definitely fit me and it stuck! LOL

At an early age, she borrowed a friend's bike, jumped a hill on Plyer Lake Rd., and went flying over a city police car. She got off lucky. They told her to just GO HOME!!

One of the first motorcycles she owned was a 750 Honda and later to purchase her Harley Davidson, a '97 Heritage Softail and a '93 883 Sportster known as "The Fatster" and still owns (which her and a friend tore it down and built). She joined the Hog Chapter in '96, and was a very active member supporting Holy Angels, Webb St. School and various other causes. Received a perfect attendance award recognition. And trophies, Lord she's won more than Carter has pills! The big one was at the Big Daddy Rat Show in Daytona, FL., placing 7th place. Received The Governors Award, was a motorcycle course instructor, taught several women on her own how to ride, appeared in the local Gaston Gazette in numerous articles, raced at Shady Side Dragstrip and won! Guy said~ "Hey fella, that's no stock bike"... Removing her helmet, her blonde hair dropped out..."Hey, he said, you're not a guy!!!" Yeah she smoked him!

Highly respected in the Biker world, and will tell you in a hot minute she is NO one's Bitch!! Has always been my go to for advice since I started riding my own in '09. I so look forward to riding with her again this spring.

So if you are thinking about learning to ride your own... Don't wait... Life's way too short! There's NOTHING like the freedom, knees in the breeze, wind in your face and bus in your teeth. You're never TO OLD to learn. Most Harley Davidson dealerships offer the riding class and so does Gaston College. I highly recommend taking it! Put it on your BUCKET LIST... What are you waiting for???

Thank you Ruthie for allowing me to spotlight you this month. I could have written many pages more on her but Jill limits me to usually a page...LOL

Hi, this is Kurt Brandt, and this is a motorcycle story. The joy we get from riding our motorcycles can be interrupted in a blink of your eye. I have ridden over 500,000 miles since starting in 1974. Back in 2005 I had a new Road Glide purchase in Dec 2014 that I was taking on a two-week trip out west trying to hit all the states west of the Mississippi. I left Sarasota, Florida on July 1 and headed out loaded up to camp as I went. I stopped in Mississippi and purchased a cell phone my first one. (old flip phone) Onward I went riding from 8 am till 10 pm. Was making great time. Made it into Montana and stopped for night on the 4th. Next morning went in North entrance of Yellowstone past the hot springs spent the day and went out the west entrance. It does not get dark there in the summer until nearly 10 so I was pushing to make Missoula MT to stop for the night. I was doing everything wrong. The speed limit was 80 mph, so I was running 85 with the cruise on. I was pushing it did not even stop for dinner. Came to a rest area and needed to stop. When I got to the entrance it was closed and I found myself looking to see why. Since I was going 85 (125 ft sec) I was coming to the exit lane quick and I really had to go. I looked in my mirror to see if I could stop and there were cars behind me. As I was looking in the mirror I decided to go on to Missoula.

I look up from the mirror to the road ahead and there stood a mule deer in my lane. The first thing that came in my head was a quote from my club in Florida that a motorcyclist and a jet fighter pilot must have same reaction times. The next thing to come into my head was this must be what a fighter pilot feels like when he has radar lock of an enemy on his ass. I clicked off the cruise and thought MOVE. I had tried to drive around a coyote before and he ran in front of me. I aimed for the deer and hoped. It did not work. Next thing I was doing a superman through the air and I thought I was going to die. I came down on my backside and started rolling. As I was rolling the bike passed me on the highway leaving a rooster tail of sparks as it slid down the road.

I stopped laying on my stomach and gathered myself and I was alive. Pushed up and knew I was hurt from the pain in my chest and ribs. I wandered over to the bike to grab the cell phone and the fairing compartment was broken and it was gone. Walked back the side of the rode and laid down and started to pray.

A husband and wife off duty county officers appeared above me and asked if I was OK. Of course, I answer I was alive but was having trouble breathing. They had called the ambulance and proceeded to direct traffic and pick up everything out of the bike down to the batteries out of the camera.

The ambulance came and I told them I could take off my jacket, but they cut it off. After all that they got me a sheet and were going to pick me up on the gurney. The head man said three and they picked up. The poor little lady on my right said "boy you are a big one". I pulled my oxygen mask and apologized.

The chopper landed next and as they were transferring me to their gurney, the little lady stepped back for the paramedics. As they lifted they also commented on my girth. As they were loading me on the chopper, they tried to break my leg inside the chopper.

It was quick ride to the hospital, and they ran through a cat scan and I don't know what else. I ended up in a bed and a beautiful little blond lady doctor came in and introduced herself. She commented I was a lucky man and I said I agreed I was alive. She answered yes but she was the surgeon, and she didn't have to operate.

Hit the deer at 10:45 and it as 2:00 am and she asked if I needed to call anyone. I said let us wait till morning. She came back in the morning and we called Sandy at work and she broke the news to her then gave me the phone. Being all jacked up on morphine I sounded like a toon from Rodger Rabbit. Told her not to come and she was there the next day. 12 days later two lung cavity drains we rented a minivan and struggled for three days to get back to Sarasota.

After three months nursing the broken ribs and the shattered right shoulder blade found out that I had completely detached my left shoulder. I had a good surgeon and he repaired it for me. After rehab I was ready before the bike was back from the shop. 200000 miles later I sold it and moved on to a newer bike.
